

TUCSON SPEEDWAY CAR and PIT STALL REGISTRATION
2024 NASCAR/INEX Race Season

NASCAR License: All drivers **MUST** buy a NASCAR license. License is optional for others including: crew, family, etc. Annual license covers Tucson Speedway's January – December **2024** race season. A 15 day NASCAR License may be purchased for \$50.00 (Charger or Pit Crew) and \$50.00 (Super Late Model) which can be applied toward your full license if you choose. Drivers must hold a full permanent NASCAR License to be eligible for yearend awards.

INEX / Track Membership: Legend and Bandolero drivers **must** be a **INEX Member**, even if they have a NASCAR license. Bandolero drivers (Bandits 6-11 yrs) (Outlaws 12-16 yrs). INEX requires you to complete license information online.

Race Night: Pit Admission for NASCAR members is **\$30.00**, non-members is **\$40.00** and kids 10 and under **\$10.00**. **NOTE: Drivers must pay entry fees / purchase a pit pass for each class they race in each race night.**

Car Numbers: All car numbers must be registered for **\$30.00 per class, per season**. Duplicate numbers are not allowed in any class. The car owner/driver who reserved the number **and participated** last season has first choice to that number. If the number was not reserved **and ran** last season, the car finishing the highest in the **2023** points season will have first option to register the number. **Thereafter, the received date of the form will determine the number assignment.** Any **1, 2 or 3 digit** number is allowed.

Pit Stalls: Pit stalls will cost **\$150.00 each - No electricity is provided.** The person who reserved the stall **and participated** in the **2023** season will have first choice for that stall in the **2024** season. **For Special Events or when your division(s) is not scheduled to run, the stall may be used by other participants at any time.** You need to reserve your pit stall as soon as possible or it will be released and reassigned by **February 20, 2024.**

Motorhome/Camp Trailer Parking: An annual storage fee of **\$300.00** will be charged for leaving a Motorhome/Camp Trailer at the track for the season. **No electricity is provided.**

NOTE: All car owners or drivers (whomever is going to receive pay and year-end tax information) must complete and submit a W-9 form with the registration form to receive payout winnings. Each individual must complete a separate registration form.
